Announcement - Change in the Credit Ratings of UBS AG

The Manager of the Fund would like to announce that Standard & Poor’s Ratings Services (“**S&P**”) has downgraded the credit ratings of UBS AG (“**UBS**”).

UBS AG, London Branch is an AXP issuer of W.I.S.E. – SSE 50 China Tracker®* (*This is a synthetic ETF) (the “**Fund**”).

S&P has downgraded the long term issuer credit rating of UBS AG from A+ to A.

As at the date of this Announcement, the credit ratings for the long term senior debt of UBS remain above the minimum credit rating requirement as disclosed in the Prospectus.

The Manager is not aware of any event which would materially affect the fitness or properness of UBS AG, London Branch to act as an AXP issuer of the Fund.

The Manager will closely monitor the situation and, as necessary, take such actions as

reasonably and practicably available to it in the event of further changes affecting the credit ratings of UBS.
