





















Certain sub-funds of the Umbrella Unit Trust³ and/or ITCIS¹ may invest in China A-shares and/or RMB denominated and settled debt instruments issued or distributed outside and/or within Mainland China. The BOC-Prudential Core Accumulation Fund's aggregate exposure to any China A-shares shall not exceed 10% of its net asset value and its aggregate exposure to RMB denominated and settled debt instruments shall not exceed 15% of its net asset value. The sub-funds of the Umbrella Unit Trust³ may invest in ITCIS¹ and Other Permitted Securities¹⁵ (which include up to 10% of its total NAV in Other Authorized Unit Trusts or Authorized Mutual Funds¹⁶).

The BOC-Prudential Core Accumulation Fund adopts the following investment strategy: it utilizes index tracking ITCIS¹ and/ or actively managed sub-funds of the Umbrella Unit Trust³ to provide exposure to equity and bond markets. 

中銀保誠65歲後基金旨在透過環球分散方式投資為計劃成員的 退休積蓄提供平穩增值。中銀保誠65歲後基金旨在達致一個以 參考組合作為相應參考之表現。然而,中銀保誠65歲後基金的 表現可能與參考組合的表現有所偏差。潛在偏差有可能源於基 礎資產組成、市場流動性及轉換基礎投資組合的時差等因素。

中銀保誠 65歲後基金目標透過投資於傘子單位信託⁹的股票子基金及/或緊貼指數集體投資計劃之組合,持有其20%資產於較高風險資產¹⁷,其餘資產則透過投資於傘子單位信託⁸的債債券子基金及/或緊貼指數集體投資計劃之組合,投資於較低風險資產¹⁸。較高風險資產¹⁷的資產分佈或會因為不同股票及債券市場的價格走勢有別而在15%至25%之間上落。

位信託或認可互惠基金

中銀保誠65歲後基金採取以下投資策略:利用緊貼指數集體投資計劃及/或積極管理傘子單位信託⁹的子基金,以參與股票及債券市場。受預設投資策略相關的強積金法例及要求的規限 下,投資經理擁有酌情權按其決定的比例靈活分配資產於傘子單位信託⁹子基金及/或緊貼指數集體投資計劃。中銀保誠 65歲後基金的風險程度一般被視為中²。

The investment objective of the BOC-Prudential Age 65 Plus Fund is to seek to provide stable growth for the retirement savings to members by investing in a globally diversified manner. It aims to achieve a performance that is referenced against the Reference Portfolio. However, it should be noted that the performance of the BOC-Prudential Age 65 Plus Fund and the performance of the Reference Portfolio may diverge. Potential divergence may be caused by factors such as composition of the underlying assets, liquidity of the market and timing differences for changes to the underlying investment portfolio.

The BOC-Prudential Age 65 Plus Fund targets to hold 20% of its assets in higher risk assets ¹⁷ through investing in a combination of equity sub-funds of the Umbrella Unit Trust⁹ and/or ITCIS¹, with the remainder investing in lower risk assets¹⁸ through investing in a combination of bond sub-funds of the Umbrella Unit Trust⁹ and/ or ITCIS[†]. The asset allocation of higher risk assets¹⁷ may vary between 15% and 25% due to differing price movements of various equity and bond markets.

In order to achieve the investment objective, the BOC-Prudential Age 65 Plus Fund will be structured as a portfolio management fund investing in two or more sub-funds of the Umbrella Unit Trust⁹ and/or ITCIS¹ which may be the ITCIS¹ managed by the Investment Manager or the ITCIS[†] selected from those available in the markets. Certain sub-funds of the Umbrella Unit Trust[§] and/or ITCIS[†] may invest in China A-shares and/or RMB denominated and settled debt instruments issued or distributed outside and/or within Mainland China. The BOC-Prudential Age 65 Plus Fund's aggregate exposure to any China A-shares shall not exceed 10% of its net exposure to any China A-shares shall not exceed 10% of its het asset value and its aggregate exposure to RMB denominated and settled debt instruments shall not exceed 15% of its net asset value. The sub-funds of the Umbrella Unit Trust[§] may invest in ITCIS[†] and Other Permitted Securities¹⁵ (which include up to 10% of its total NAV in Other Authorized Unit Trusts or Authorized Mutual Funds¹⁶).

The BOC-Prudential Age 65 Plus Fund adopts the following investment strategy: it utilizes index tracking ITCIS[†] and/or actively managed sub-funds of the Umbrella Unit Trust⁹ to provide exposure to equity and bond markets. The Investment Manager may, subject to the DIS-related MPF legislation and requirements, have the flexibility to allocate the assets among sub-funds of the Umbrella Unit Trust and/or ITCIS (s) in such proportions as it shall, at its discretion, determine. The risk level of the BOC-Prudential Age 65 Plus Fund is medium².

市場概覽⁸ MARKET OVERVIEW⁸

環球經濟增長放緩但維持穩定,各地區表現分化。環球通脹放緩,為主要央行進一步減息提供了有利條件。美國經濟依然穩健,服務業表現強勁,但勞動力市場有所降溫。中國經濟表現平平,但隨著市場預期美國下屆政府可能加徵關稅,從而使需求有所提前下,臨近年底出口有所改善。在歐洲,德國和法國製造業數據均走弱,可能預示著該地區面臨進一步下行風險。在此宏觀背景下,聯儲局和歐洲央行季內分別減息50個基點,而中國人民銀行則保持寬鬆的貨幣政策以支持經濟。

Global growth softened yet remained stable, with dispersion across regions. Declining global inflation provided a supportive case for major central banks to further reduce interest rates. US economy remained solid with a resilient services sector while the labour market cooled. China's lackluster economy saw improving exports towards the year-end on front-loading demands ahead of potential tariff threats from the incoming US administration. In Europe, weaker manufacturing readings in both Germany and France might signal further downside risks in the region. Against such macro backdrop, the Fed and ECB lowered policy rates by 50 basis points during the quarter, while PBOC kept monetary policy accommodative to support the economy.

基金經理評論 8 MANAGER'S COMMENT8

中銀保誠中國股票基金 BOC-Prudential China Equity Fund

2024年第4季,中國內地基準指數漲跌互現,以指數基數貨幣計,在岸市場表現優於離岸市場。由於中美息差擴闊,美元對人民幣走強。去年10月,中國內地股市在黃金周假期後從峰值水平回落,並在下半月於區間內波動。在企業盈利前景的不確定性上升下,國內政策刺激仍缺乏關鍵細節。去年11月,中國股市表現參差,在岸股指表現優於離岸股指。散戶投資者憧憬即將召開的中央經濟工作會議將出台更多刺激措施,在岸市場情緒得到提振,而離岸投資者對新一屆特朗普政府下的中美關係看法趨向悲觀。去年12月,在中央政治局會議提到實施「適度寬鬆」的貨幣政策後,市場反應正面。然而,隨後的中央經濟工作會議在消費者和房地產政策方面未有更多積極信號。去年第4季,上證綜合指數和深證綜合指數分別上漲0.5%和1.6%,滬深300指數和創業板指數則分別下跌2.1%和1.5%,而恒生中國企業指數和恒生科技指數分別下跌2.9%和6.0%。資訊科技和金融服務板塊表現最為領先,而地產和原材料板塊則表現最為落後。

本基金在第4季錄得負回報,主要受消費相關及科技相關持股的下跌拖累。在新一屆特朗普政府上任後,美國關稅風險可能成為現實,加上中國國內假期消費增長可能面臨高基數效應而受壓,本基金預計中國股市在2025年第1季將會在區間內波動。雖然直到2025年3月兩會前未有公佈新的政策寬鬆之細節,但隨著監管機構承諾穩定股市,市場下行幅度可能有限。得益於強勁的穩增長政策訊號和財政狀況有所改善,地方政府支出可能會增加。

本基金將於2025年第1季保持多元化和均衡的部署,並關注以下3個主題:1)供應受限且經營穩定的產業,例如電信、公用、能源、由少數國營企業主導的行業;2)估值具吸引力、且可能受進口替代或海外擴張所帶動而需求前景良好的高端製造業;3)能夠適應當前宏觀背景的新消費趨勢。風險方面,本基金將密切關注:(1)美國新一屆政府及其對環球增長前景的影響;(1)在通脹壓力減弱的情況下,聯儲局的政策立場較預期鷹派;(11)中國勞動力市場、商業信心和收入預期的復甦步伐;(14)對房地產、政府支出和大型科技公司監管的支持性政策之影響;(14)地緣政治不確定性,包括但不限於中美緊張局勢。

Mainland benchmark indices were mixed in 4Q24 with onshore market outperforming offshore in terms of local currencies. CNY depreciated against US dollar given the widening interest rate spread between China and US. In October, China equity markets retreated from the peak after the Golden Week holiday and stayed range-bound for the second half of the month. Domestic policy stimulus still lacks key specifics with rising uncertainties from corporate earnings outlook. In November, China equity markets performances were mixed with onshore indices outperforming offshore. Onshore market sentiments held up better thanks to retail participations amid hopes for more stimulus, while offshore investors were turning more pessimistic on US-China relationships under the new Trump administrations. In December, market responded positively after politburo meeting mentioned the adaptation of a "moderately loose" monetary policy. However, the subsequent CEWC meeting was lacking incremental positive signals regarding consumer and property policy approaches. Shanghai Composite, Shenzhen Composite, CSI300, and ChiNext Index changed by 0.5%, 1.6%, -2.1%, and -1.5% respectively in the fourth quarter, while HSCEI and HSTECH Index changed by -2.9% and -6.0% respectively. Information Technology and Financial Services were the best performing sectors while Property and Basic Materials were the worst.

The Fund registered a negative return in the fourth quarter, led by the losses in Consumption related and Technology related exposures. The Fund expects range bound with volatility for China equity market in 1Q25, as US tariff risks could materialize after the new Trump administration takes office and China domestic holiday spending could see growth headwinds given the high base effect. While there is a lack of new policy easing details till Two Sessions in Mar 2025, market downside could be protected as regulators pledged to stabilize the stock market. Local government spending could step up thanks to the strong pro-growth policy signal and improved fiscal positions.

The Fund will maintain a diversified and balance position in 1Q25 while closely monitor the below three themes: 1) supply constrained sectors with stable operations, such as telecommunication/utilities/energy/ sectors which dominated by a few SOEs; 2) advanced manufacturing at attractive valuations with favourable demand outlook, likely driven by import substitution or oversea expansion; 3) new consumption trends that are well positioned under the current macro backdrop. For the risks aspect, the Fund would closely monitor: (i) New US administration policy and its implications to global growth outlook; (ii) More than expected hawkish policy stance by Fed amid softening inflation pressures; (iii) Pace of recovery regarding labour market, business confidence and income expectation in China; (iv) Effects of supportive policy regarding property, government spending and large tech companies' regulations; (v) Geopolitical uncertainties including but not limited to Sino-U.S. tension.

中銀保誠香港股票基金 BOC-Prudential Hong Kong Equity Fund

去年10月,中國新的政策刺激未能滿足投資者的高預期,導致市場普遍出現獲利了結,香港股市收低。在特朗普勝選後關稅威脅上升以及中國全國人大會議的 刺激措施未達預期下,恒生指數去年11月進一步下跌。此外,地緣政治緊張局勢持續,美國準備對用於人工智能開發的晶片銷往中國實施新的限制措施。在中 央政治局會議和中央經濟工作會議加強了對寬鬆立場和穩定房地產及股市的承諾,提振了市場樂觀情緒,去年12月市場有所反彈。整體而言,通訊和金融服務 板塊分別受惠於企業業績強勁與避險情緒上升,表現最為領先,而原材料和健康護理板塊則主要受關稅風險上升及潛在的制裁風險拖累,表現最為落後。

本基金於去年第4季的表現落後於下跌的基準,主要受金融和消費相關板塊的持股所影響。在特朗普政府確認重返白宮後,去年第4季市場回吐了去年9月底的巨大漲幅,但在市場預期中國出台更多大規模刺激措施下,下跌有所放緩。在關稅和制裁風險上升及2025年美國利率路徑存在不確定性下,市場波動性高企,本基金將保持審慎立場,並可能會藉著過度的市場波動來優化持股,聚焦於企業業務與盈利的可持續性、財務實力以及從政府新刺激或制裁措施中受益的可能性。

Hong Kong market closed lower in October as China's new stimulus package failed to meet investors' high expectations, leading to profit-taking across the board. Hang Seng Index declined further in November, due to rising tariff threats following Trump's victory and the underwhelming stimulus from the China's National People's Congress meeting. Additionally, geopolitical tensions persisted, with the US preparing to implement new restrictions on China's chip access for Al development. Market rebounded in December, as sentiment received a boost from rising optimism after Politburo meeting and CEWC reinforced their easing stance and commitment to stabilize the property and stock markets. Overall for the quarter, the best performers of the local market included Telecom sector, driven by strong corporate results, and Financials sector, as risk-off sentiment prevailed. Basic Materials and Health Care sectors lagged, mainly due to rising tariff risks and potential sanction risks.

The Fund underperformed benchmark's decline in the fourth quarter, mainly due to the Financials and Consumption related exposure. The massive late-September rally retreated in the year's final quarter after the confirmed return of Trump administration in US, but the anticipation of more outsized stimulus packages to be rolled out in China moderated the pull-back. With elevated market volatility because of rising tariff and sanction risks as well as the uncertainty of US interest rate trajectory in 2025, the Fund will stay vigilant in coming months and may leverage on excessive market fluctuation to adjust portfolio exposure by focusing on corporates' business and earning sustainability, financial strength, and beneficial likelihood from new government stimulus or sanctions.

中銀保誠日本股票基金 BOC-Prudential Japan Equity Fund

由於淨出口和資本支出好轉,日本去年第3季國內生產總值獲上調。儘管消費物價指數上升,但近期零售銷售有所改善,且商業情緒整體正面。日本經濟基本符合日本央行的預期,並支持其再次加息。然而,央行在最近一次會議上維持利率不變,並表示對薪酬趨勢和美國政策不確定性的擔憂。央行還重申,為實現可持續通脹,金融環境將保持實鬆。日本央行的鴿派立場降低了市場對其大幅加息的預期,推動日圓在去年第4季進一步貶值。

以港元計,日本股市去年第4季下跌,期內表現領先美國股市以外的大多數主要市場。日圓走低支撐了市場,但圍繞美國總統大選後的政策、地緣政治風險和當前 財報季的不確定性持續存在。外國投資者仍在觀望,而企業回購或將繼續填補缺口。原材料股表現落後,而金融股表現最為領先。

本基金第4季錄得輕微負回報。金融相關持股對表現的拖累,部分為科技板塊所抵銷。展望2025年,在美國新任政府上台後,日本央行的加息路徑和全球地緣政治環境可能會變得更加清晰。本基金將採取更加中性的立場以平衡風險和回報。

Japan's third quarter GDP was revised up due to better net exports and capital expenditure. Recent retail sales improved despite higher CPI, while business sentiment was generally positive. The economy was largely consistent with BoJ's forecasts and supportive for another rate hike. However, the central bank instead kept the interest rate unchanged in its latest meeting and cited concern on wage trend and policy uncertainty of US. It also reiterated that financial conditions would remain accommodative in pursuit of sustainable inflation. The dovish stance of the Bank cooled market expectation of a steep rate hike path, driving Yen to depreciate further during the quarter.

Japan equity market dropped in the fourth quarter in HK dollar terms and outperformed most major markets except US equities during the period. Lower Yen supported the market, however, uncertainty over the policies of US President-elect, geopolitical risks and current reporting seasons persisted. Foreign investors remained on the sidelines while Corporate buyback would likely continue to fill the gap. Materials sector underperformed while Financials related names contributed the most.

The Fund posted a slight negative return in the fourth quarter. Financials related names dragged the performance while Technology sector reduced the loss. Looking ahead to 2025, BoJ's rate hike path and global geopolitical environment would likely become clearer after the new US government takes hold. The Fund would adopt a more neutral stance to balance between risk and return.

中銀保誠亞洲股票基金 BOC-Prudential Asia Equity Fund

亞洲經濟勢頭大致能保持,但出口活動與本地需求仍不匹配。技術升級周期延長,以及一些在美國可能加徵關税前提前的訂單,支撐了出口。儘管本地消費需求放緩,由於政府推出的刺激計劃開始利好實體經濟,中國的採購經理指數仍攀升至擴張水平。同時,大多數亞洲經濟體的通脹都得以控制在較低水平,但貨幣貶值使燃料價格的上行壓力輕微增加。通脹放緩和經濟逆風為韓國、菲律賓、泰國和新西蘭等國的減息提供了良好的基礎。然而,聯儲局預計2025年放慢減息步伐,將限制亞洲進一步放鬆貨幣政策。

本基金於季內錄得負回報。印度非必需消費板塊的選股拖累表現,但被台灣科技板塊的正面選股所抵銷。展望未來,鑑於加劇的宏觀不確定性和對持續的地緣政治局勢的擔憂,市場波動性可能仍會維持高企。投資者將關注特朗普就任總統後美國貿易政策,以及中國進一步刺激政策之力度和日程。本基金將在波動環境下專注於市場中性策略以達致較穩定的表現。

Economic momentum in Asia largely held up, but the tempo of export activities and domestic demand continued to be mismatched. Exports were supported by the prolonged tech upcycle and some front-loading orders prior to potential US tariff hike. Although consumer demand in the region was moderate, PMIs in China climbed to expansionary level because stimulus package rolled out by the government started to help the real economy. Meanwhile, inflation was well contained in low levels for most of the Asian economies, but depreciated currencies have added slight upward pressure on fuel prices. Soft inflation and economic headwinds provided good ground for cutting rates in several countries like Korea, the Philippines, Thailand and New Zealand. However, the Federal Reserve forecasting slower rate cut speed in 2025 will limit further monetary easing in Asia.

The Fund recorded negative return during the quarter. Stock selection in India Consumer Discretionary sector dragged Fund performance, offset by successful stock selection in Taiwan Technology sector. Looking ahead, market volatility is likely to remain high due to macro uncertainties and sustaining geopolitical conflicts. Investors will focus on US trade policy after Trump takes office as president, as well as magnitude and timing of China's further stimulus policies. The Fund would concentrate on market neutral strategy in a volatile environment to achieve a more stable performance.

中銀保誠環球股票基金 BOC-Prudential Global Equity Fund

Global growth softened yet remained stable, with dispersion across regions. Declining global inflation provided a supportive case for major central banks to further reduce interest rates. US economy remained solid with a resilient services sector while the labour market cooled. China's lackluster economy saw improving exports towards the year-end on front-loading demands ahead of potential tariff threats from the incoming US administration. In Europe, weaker manufacturing readings in both Germany and France might signal further downside risks in the region. Against such macro backdrop, the Fed and ECB lowered policy rates by 50 basis points during the quarter, while PBOC kept monetary policy accommodative to support the economy.

Global equity index ended 4Q 2024 with a loss. The escalation of the Middle East conflict first triggered a surge in oil prices and risk-off sentiment in the broad market. Investor risk appetite later returned in US market after Donald Trump's presidential victory, but remained suppressed in other regions on rising concerns over another global trade war. A less dovish Fed and climbing US Treasury yields also put downward pressure on equities prices. All regional markets except for North America finished the year with a negative quarter. Material stocks were the worst performer as commodity prices were pressured by US dollar strength and restrained demand from China, while Consumer Discretionary sector outperformed.

The Fund had adopted a more balanced view across regions, with its underweight in US equities and its overweight in other non-US regions being reduced to a more neutral position, taking into consideration of differences in macroeconomic outlooks and relative market valuations. Should developments in financial condition, inflation and monetary policy change, the Fund may adjust its regional allocation and tactical portfolio stance.

中銀保誠中證香港100指數基金 BOC-Prudential CSI HK 100 Tracker Fund

中證香港 100 總回報指數於 2024 年第 4 季下跌。根據香港金融管理局(HKMA)的數據,貨幣基礎總結餘維持在 450 億港元左右。

本地經濟方面,2024年首11個月零售業總銷售價值初步估計數字,較2023年同期下跌7.1%。2024年首11個月的貨物出口總額按年上升9.1%,而同期的貨物進口總額則按年上升6.7%。以2024年首11個月計算,輸往部分主要目的地的整體出口貨值錄得按年升幅,尤其是越南、泰國、中國內地及美國。

CSI Hong Kong 100 Total Return Index dropped in the fourth quarter of 2024 (Q4). According to the Hong Kong Monetary Authority (HKMA), the aggregate balance of monetary base staying at around HKD 45.0 billion.

As to the domestic economy, the provisionally estimated value of total retail sales for the first 11 months of 2024 decreased by 7.1% compared with the same period in 2023. The value of total exports of goods increased by 9.1% year-on-year (YoY) for the first 11 months of 2024 while the value of imports of goods increased by 6.7% YoY in the same period. For the first 11 months of 2024, year-on-year increases were registered in the values of total exports to some major destinations, in particular Vietnam, Thailand, Mainland China, and the USA.

The Fund posted a negative return in Q4.

中銀保誠歐洲指數追蹤基金 BOC-Prudential European Index Tracking Fund

國內生產總值方面,2024年第3季歐元區國內生產總值為0.4%。11月失業率為6.3%,與10月持平。採購經理指數方面,第3季歐元區採購經理指數的平均值為45.4。

本基金於2024年第4季錄得負回報,與大市相比表現落後。國家篩選方面,英國的相對偏低比重對表現的利淡,部分為法國的相對偏低比重所抵銷。行業篩選方面,相對市場而言,非必需消費行業的偏低比重利淡表現,健康護理行業的偏低比重則帶來了正主動回報。

The European Central Bank cut its key interest rate twice by 0.25 percentage point to 3.00% amid signs of weakening growth and concern about the impact of political chaos in France and the possibility of new U.S. import tariffs after Donald Trump takes office as president. French Prime Minister Michel Barnier resigned, following the breakup of Germany's governing coalition in November. The political chaos in France and Germany could derail the competitiveness of Eurozone further. With respect to economic sentiment, the latest consumer confidence index came in at -14.5 in December from -13.8 the previous month. Latest Eurozone Manufacturing arrived at 45.2 in December, remaining unchanged from the previous month.

Concerning Gross Domestic Product (GDP), the Eurozone GDP was 0.4% in the third quarter of 2024. Unemployment rate was 6.3% in November, unchanged from October's reading. With respect to Purchasing Managers Index (PMI), the Eurozone PMI reached an average of 45.4 over the third quarter.

In the last quarter of 2024, the Fund reported a negative return with underperformance comparing to the market. For country selection, the underperformance was contributed by underweighting in United Kingdom while underweighting in France offset some of the underperformance. In regard to sector selection, underweighting in Consumer Discretionary sector contributed to the underperformance, while underweighting in Health Care sector generated positive active return against the market.

On data front during the quarter, NASDAQ and S&P 500 surged by 6.17% and 2.07%, while Dow Jones Industrial Average is up a mere of 0.51%. The Manufacturing Purchasing Managers' Index was at 49.4 in December, down from 49.7 in November.

Corporate bond exposure provided some offsets, as favorable technical backdrops alongside the still solid corporate fundamentals, supported credit spreads performance. Looking ahead, the level of uncertainty surrounding policy outlook is high, especially after the U.S. election confirming Trump's return to the White House. We believe market volatility will likely persist, with investors scrutinizing developments of data and policy, alongside the ongoing geopolitical tensions. We stay with a sense of caution towards credit market, where current valuation has seemingly underpriced risk of potential economic downturn as well as geopolitical uncertainty. Prudent security selection will be the key to keep risk tightly controlled in portfolios.

The risk levels are determined by the Investment Manager based on the investment mix of each Constituent Fund and/or its underlying investments, and represent only the views of the Investment Manager. The risk levels are for reference only and will be reviewed and (if appropriate) updated at least annually taking into account the prevailing market circumstances. The risk levels are determined based on data as at 31 December 2024²⁰.
- 3. The Fund Risk Indicator is shown as an annualized standard deviation based on the monthly rates of return of the fund over the past 3 years to the reporting date. In general, the higher the Fund Risk Indicator, the higher the risk level of the fund.
 - The Fund Risk Indicator of DIS Funds is calculated since 3 April 2017 (if applicable) which was the first dealing day after 1 April 2017.
 - The Fund Risk Indicator of BOC-Prudential Hong Kong Stable Retirement Fund will be shown from the fourth quarter of 2025 (3 years after the launch of the Fund).
- 4. The risk class is to be assigned to each Constituent Fund according to the seven-point risk classification below based on the latest fund risk indicator³ of the Constituent Fund in accordance with the part D2.3(j) of Code on Disclosure for MPF Investment Fund issued by the MPFA¹¹. Fund with performance history of less than 3 years since inception to the reporting of the fund fact sheet is not required to show the risk indicator³ in the fund fact sheet, hence the risk class is not available. The above risk classes will normally be updated within 2 months after each quarter and are assigned based on data of the relevant Constituent Fund as at the quarter end date.

Please note that the above risk classes are prescribed by the MPFA¹¹ according to the Code on Disclosure for MPF Investment Funds and have not been reviewed or endorsed by the Securities and Futures Commission
