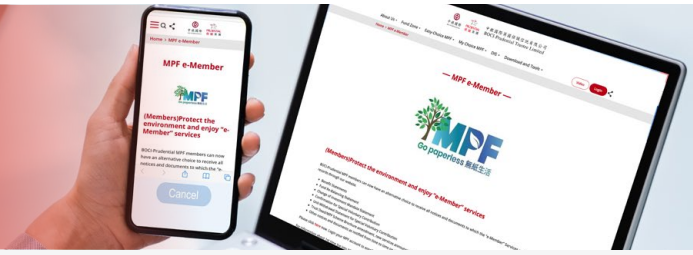

更新強積金服務渠道 Updates on MPF Service Channels



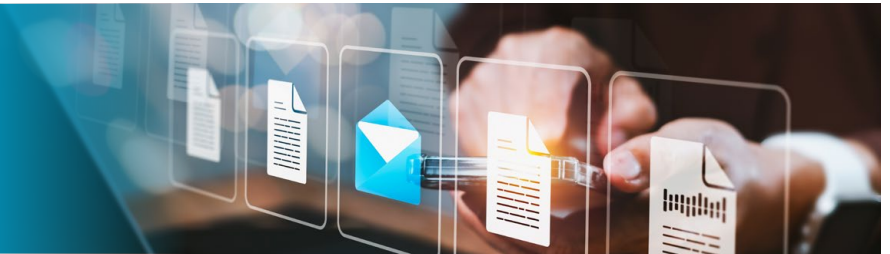
由2024年6月6日起，透過南洋商業銀行有限公司的自動櫃員機及存支票機提供之強積金服務將會暫停。

eMPF is a new electronic platform to allow employers and members to manage MPF account in a one-stop manner. On 26 June, the first trustee successfully migrated to the eMPF platform, and other MPF trustees will gradually onboard to the eMPF platform according to the [Schedule](#). Currently, the tentative schedule for BOCPT to onboard to the eMPF platform is the first/second quarter of 2025. We shall issue the eMPF communication pack in due course. Employers and scheme members are advised to read carefully the relevant document and pay attention to the various matters during the transitional period. To ensure you can receive important information about eMPF timely, please keep your correspondence address, phone number and email address at the Trustee’s record up-to-date. If you need to update your contact details, please login [Trustee’s website](#) or complete the [Change of Scheme Member’s Particulars Form](#).

Starting from mid-June, the eMPF Platform has begun providing support services to assist employers and members in migrating to the eMPF platform. For details, please visit the [eMPF website](#).
