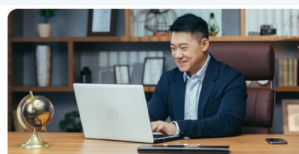

短訊發送人登記制 Short Message Service (SMS) Sender Registration Scheme



中銀國際英國保誠信託有限公司(「信託公司」)最近已登記參與「短訊發送人登記制」。自2024年12月23日起,信託公司在發送短訊給客戶時,已陸續使用以「#」號開頭的「已登記的短訊發送人名稱」(包括#BOCPT和#BOCPT_ECMP)發送短訊至客戶的已登記流動電話號碼。

請注意,「短訊發送人登記制」並不適用於:

1. 使用非香港營辦商提供之一卡多號/一卡雙號流動服務的本地用戶;及
2. 香港以外的地區或國家的手提電話號碼。

我們提醒客戶在任何情況下絕不要向身分未經核實的短訊發送人披露個人資料或賬戶詳情,以免蒙受損失。

BOCI-Prudential Trustee Limited (the "Trustee") has registered to participate in the "SMS Sender Registration Scheme" recently. From 23 December 2024 onwards, the Trustee has started using the "Registered SMS Sender IDs" with prefix "#" (including #BOCPT and #BOCPT_ECMP) when delivering SMS messages to customers' registered mobile phone numbers.

Please note that the "SMS Sender Registration Scheme" is not applicable to:

1. Local users of Single-Card-Multiple-Numbers/One-Card-Two-Numbers mobile service provided by non-Hong Kong operators; and
2. Mobile phone numbers of a region/country outside Hong Kong

We would like to remind customers that they should never disclose personal information or account details to unverified SMS senders under any circumstances, to avoid suffering from any loss.

The eMPF Platform is a brand new electronic platform that enables employers and members to achieve all-in-one management of MPF accounts. The first MPF trustee has onboarded the eMPF platform on 26 June 2024. Other trustees are gradually onboarding the eMPF platform according to the [Schedule](#). BOCPT is expected to onboard the eMPF platform in the second quarter of 2025. The Trustee will issue the eMPF communication pack in due course. Employers and scheme members are advised to read carefully the relevant documents and pay attention to relevant matters during the transitional period. To ensure you can receive important information about eMPF in a timely manner, please make sure your correspondence address, phone number and email address registered with the Trustee are up-to-date and correct. If you need to update your contact details, please login the [Trustee's website](#) and complete the [Change of Scheme Member's Particulars Form](#).

Starting from mid-June 2024, the eMPF Platform has begun providing support services to assist employers and members in making a smooth transition to the eMPF platform. For details, please visit the [eMPF website](#).
