Amendment of Prospectus and Trust Deed  
and Update of Key Facts Statement**

The Manager hereby announces that the Prospectus of the Sub-Fund (the “**Prospectus**”) has been amended with effect from today (i.e. 31 December 2020) (the “**Effective Date**”). The Trust Deed of the Fund dated 11 July 2007, as amended from time to time (the “**Trust Deed**”) has also been amended by way of a deed of variation and substitution. The Key Facts Statement of the Sub-Fund (the “**KFS**”) has also been updated.

The Manager would like to inform the investors that certain minor modifications have been made to the section headed “INVESTMENT AND BORROWING RESTRICTIONS” of the Prospectus. Other updates, minor changes or modifications have also been made to the Prospectus.

The provisions relating to investment restrictions in the Trust Deed have also been amended by way of a deed of variation and substitution. Certain minor changes, modifications or adjustment of wording have also been made to the Trust Deed.

The aforesaid amendments to the Prospectus and Trust Deed are effective on the Effective Date.

In the meantime, the information relating to the number of listed companies and total market capitalization of the Shenzhen Stock Exchange and Shanghai Stock Exchange as set out in the Prospectus, and the percentage of the total market capitalisation of the Shenzhen Stock Exchange and the Shanghai Stock Exchange that the 300 constituent stocks of the CSI 300 Index represent as set out in the Prospectus and KFS has been updated.

The information relating to the ongoing charges in the KFS has also been updated.

The amendments to the Prospectus and Trust Deed will not have any adverse impact on the Unitholders. There is no change to the investment and borrowing limits applicable to the Sub-Fund, the level of fees payable by the Sub-Fund and the Unitholders, or the manner in which the Sub-Fund is being managed.
