

BOCHK Hong Kong Dollar Income Fund

Monthly Highlight

November 2021 (Data as of 29/10/2021)

Key Features and Risk Disclosure:

- The BOCHK Hong Kong Dollar Income Fund (the "Sub-Fund") seeks to provide a stable income stream and long-term capital appreciation through investing at least 70% of its non-cash assets in a portfolio which mainly consists of Hong Kong dollar denominated investment grade bonds. The Sub-Fund may invest not more than 30% of its Net Asset Value in debt instruments with loss-absorption features (LAP).

Market Comment and Fund Comment[#]

Market Comment

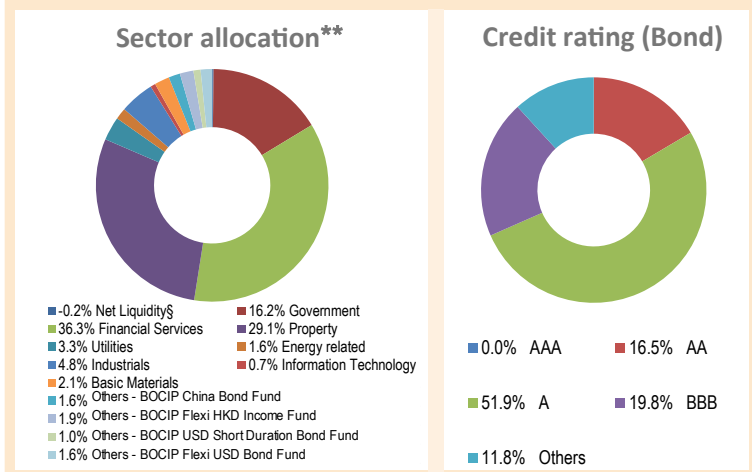
- Hong Kong dollar (HKD) bond markets further weakened into October. Bond yields rose, led by the medium-to-longer maturities.
- Outperformance of short-dated bonds came in contrast to those in the U.S., thanks to favorable liquidity conditions in the city.
- To mop up excess liquidity in the system, the Hong Kong Monetary Authority (HKMA) announced another upsizing of the 3-month Exchange Fund Bill (EFN) issuance in the next two months.

Fund Comment

- With global macro uncertainty amid virus evolution remaining, market volatility should likely stay high in the near term. As such, we adhere to a conservative approach towards duration management, whilst favoring high-quality credits for yield enhancement.

Fund Features

- ✔ Invest mainly in Hong Kong dollar denominated investment grade bonds, mitigating currency risk.
- ✔ Invest in bonds from private corporation and government, which invest across a spectrum of sectors, therefore achieving risk diversification and exposing to various opportunities from business cycle.
- ✔ As of 29/10/2021, investment grade bonds rated grade A or above account for 68.4% of the portfolio^{*}.
- ✔ As of 29/10/2021, duration of the Sub-Fund is 2.6, the 3 years annualized standard deviation is 1.1160%.

⚡ The Sub-Fund is approved as "Eligible Collective Investment Scheme" under "Capital Investment Entrant Scheme" ("CIES") of Hong Kong Special Administrative Region ("HKSAR"). 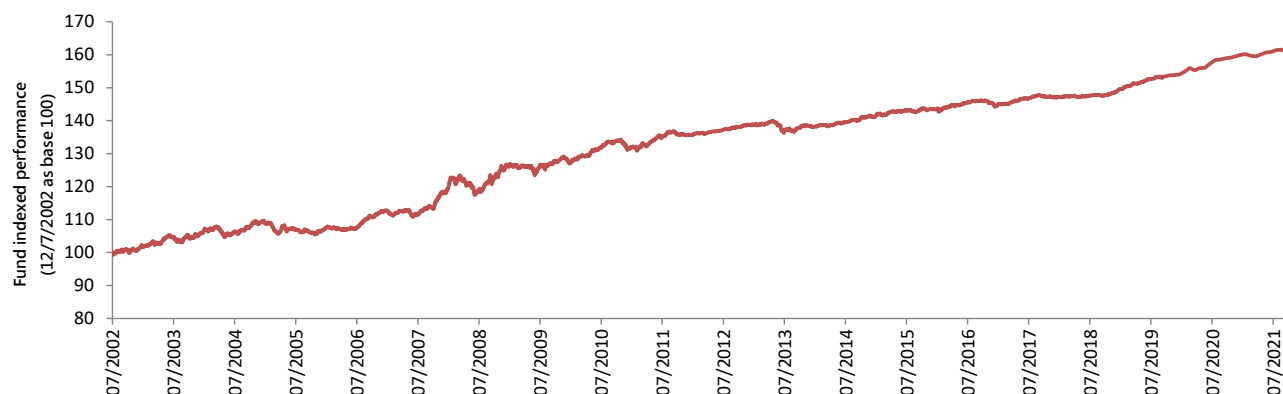

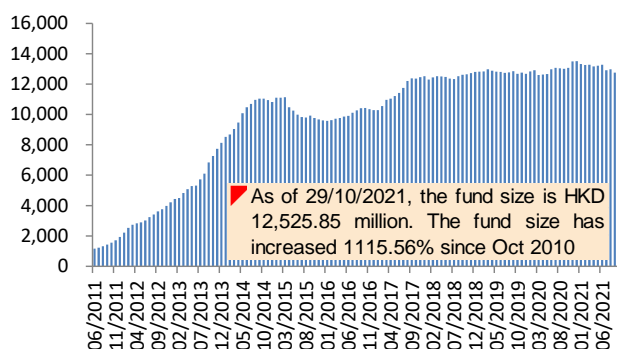

Fund Performance[△] (Since inception (12/7/2002) to 29/10/2021) (Gross Distribution Reinvested) (Class A-HKD Units)

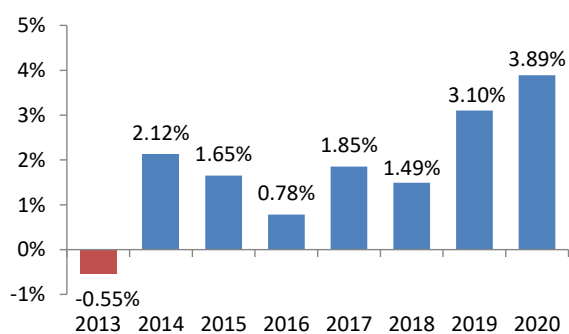
