e-Identity Verification

- Select "Employer" on the registration page and choose the e-Identity verification method: either via the "iAM Smart" mobile app or scan the HKID card and proceed to facial recognition

Fill in Information

- Fill in the personal particulars of Company Authorized Person
- Fill in Company Identification information, including the eMPF activation code

Upload Supporting Documents

- "Company Authorized Person" Appointment Form
- Company Business Registration (BR)/Certificate of Incorporation (CI)/MPF scheme correspondence

eMPF Activation

- Upon receipt of the registration application, the eMPF Platform will send a notification to the Company Authorized Person by email/SMS within two working days for activating the account
- Upon receipt of the notification for eMPF activation, the Company Authorized Person may conduct the identity verification and create a username and password via the eMPF web portal or mobile app so as to complete the eMPF activation process

- Upon receipt of an eMPF ID, click "Activate Now" to create the eMPF username and password
